\*\*Please be advised that this registration form is the initial application to join our tour for the TCS New York City Marathon 2021, and <u>does not</u> indicate you have been offered the tour package with the guaranteed race entry.

Please read the terms and conditions carefully, and complete the registration form with your choice of tour package (\*), and sign the agreement.

(\*) The tour packages in this registration form are meant for <u>single and twin share only</u>. Please write to us directly for the quotation for triple share (Courtyard Central Park only). Be advised that the rooms at the Courtyard Central Park are equipped with 2x Double Beds only and there is no provision for 3 single beds for the triple share. If you intend to bring your family, any child above 6 years old is considered an adult fare. There is no triple share package at the Residence Inn.

As we have <u>very limited race entries</u> allocated to us, we will review all applications and will send the official invoice & booking offer to the successful applicants (#).

- (\*) Runners who are living in the neighboring countries or elsewhere, please check with the official International Tour Operators serving your country for the tour packages.

  For runners living in the USA, we regret that we will not be able to accept your application.
- (#) Successful applicants must make the <u>deposit of Sin\$900 (per runner)</u> to have the <u>race entry reserved exclusively</u> for them. If the deposit is not paid within the timeline stated in the invoice, the booking will be cancelled. However, the <u>race entry will be confirmed only with the full payment of the tour package.</u>

We will inform all applicants of the outcome regardless whether you have been offered the tour packages or not. Applications that are not successful will be placed on the wait list, and we will inform you if there are any cancellations/withdrawals

# Terms and Conditions – TCS New York City Marathon 2021

#### 1) TOUR PACKAGES

Athletes' Journey is committed to offer goods & services of outstanding quality and tour descriptions of highest accuracy. Athletes' Journey reserves the right to amend tour packages as may become necessary in situations that are beyond its control, such as third-party amendments, currency fluctuations, increments in taxes and fuel surcharge, or others. In such cases Athletes' Journey will provide its clients with immediate updates on individual package components, itineraries, etc. Published and promotional package prices and verbal quotes are of indicative nature. Definite tour fares, goods and services provided are subject to written confirmation by Athletes' Journey.

## 2) RESERVATION AND BOOKING

Booking of a tour package is constituted by payment of a deposit of **Sin\$900** (per runner) of the quoted total fare. By paying a deposit the client agrees to be bound by the terms and conditions set forth herein.

#### 3) PAYMENT

Payments may be made by PayPal, credit card, bank transfer or cheque. Credit card fees and bank charges are to be paid for by the client. Receipt of full payment is required by the deadline stipulated in the customized quote and invoice. Receipt of a cheque or crediting of a bank transfer determines the date of payment. Late or incomplete payments may incur additional fees or result in the cancelation of booking under the conditions set forth in section 4.

## 4) CANCELLATIONS (#)

Cancellations of booking must be received and confirmed in writing (email). All payments are refundable, subject to \$\$100 admin fee, based on the following timeline:

## (The deposit is non-refundable from 01 May 2021)

Before 01 May 2021: 100% refund (All payments including the deposit minus the admin fee)

Between 01 May to 31 Jul 2021: 50% refund (All payments minus the deposit & admin fee)

After 31 Jul 2021: No refund

Cancellation policy may vary for customized tour packages that deviate from the standard package, such as personalized flight schedules and others. Exceptions to the cancellation policy are at the sole discretion of Athletes' Journey LLP.

## (#) Cancellation by the organisers

If the event has to be cancelled by the organisers, for whatever reason, the deposit is non-refundable, and the race entry is non-transferrable to the following year or to another runner. However, Athletes' Journey will inform you as soon as the official announcement is made, and we will advise you further on the guidelines offered by the organisers with regard to the race entry & the tour package.

## 5) TRAVEL & MEDICAL INSURANCE

It is the client's responsibility to arrange an adequate travel insurance coverage for the entire duration of travel. Athletes' Journey reserves the right to request from its clients corresponding insurance documentation at any time. Athletes' Journey recommends travel insurance with cancellation coverage (e.g. not able to travel due to medical reasons, and/or other emergency matters).

In addition to the standard coverage, please consider purchasing travel insurance to insure against the insolvency of the travel agency. #### **6) TRAVEL DOCUMENTS**

It is the client's sole responsibility to provide the necessary personal documents that are required for international travel. This includes an internationally recognized passport (valid for at least another six months after conclusion of the tour), as well as the necessary visas and/or re-entry permits where applicable. Athletes' Journey will be happy to assist with visa applications. However, Athletes' Journey is not responsible for the success of visa applications. Failure to produce valid personal travel documents may result in cancelation of the tour under the conditions set forth in section 4.

#### 7) LIABILITY

- a) Athletes' Journey acts as agent for the airlines, transport companies, hotels, race organizers and other principals of the tour packages and is not liable for changes made by suppliers but will render assistance where possible.
- b) Athletes' Journey accepts no responsibility for any injury, damage, accident, loss, delay or irregularities that may be caused to the person or property where such occur as a result of circumstances beyond its control, including but not limited to mechanical breakdowns, strikes, action of third parties or foreign authorities, acts of God and natural disasters.
- c) Athletes' Journey accepts no responsibility for situations or expenses where a client is deported or refused entry by immigration authorities on the tour for whatever reasons, including improper travel documents, quarantine, custom regulations, improper behaviour and possession of unlawful items or irregularities that may cause harm/damage to person or property.
- d) Athletes' Journey accepts no responsibility for irregularities or delays that result out of a client's failure to follow reasonable instructions by hosts and tour guides, including but not limited to compliance with proposed meeting times and venues. Furthermore, Athletes' Journey accepts no responsibility for irregularities or delays that result out of wrong, erratic, or dishonest information provided by a client about him or herself or a particular situation.

#### 8) DATA PRIVACY

Athletes' Journey will at no point disclose or share client information to third party other than those required for providing the goods and services of a specific tour package, such as the airline, the hotel, and the race organizer.
